### **TRAFFIC REGULATIONS:**

- Automobiles are permitted on designated roadways only.
- PLEASE DO NOT PARK ON THE GRASS
- No recreational riding of bicycles or motorcycles will be permitted.

### **FLOWERS/DECORATIVE TRIM:**

- Live flowers are not permitted. Artificial flowers may be planted no farther than one foot from the headstone on the sides and on the front of the stone only. Nothing is to be planted behind the stone.
- No decorative trim may be placed on burial site including but not limited to landscape stone, bricks, or wood.

### **NO GLASS CONTAINERS:**

- Winter decorations must be removed by April 1<sup>st</sup>.
- All grave decorations will be removed as they become unsightly (Usually 4-10 days)
- Cemetery personnel reserve the right to remove any such decorations when not removed by the family.

### **MAINTENANCE:**

- The cemetery personnel have sole responsibility for care and maintenance of the cemetery grounds.

- Individuals **planting of shrubbery and trees with the cemetery is strictly prohibited.**
- Any request for assistance or special services should be directed to the **trustees**. The trustees cannot accept responsibility for theft or damage to any items placed on burial spaces.

### **GENERAL RESTRICTIONS:**

- Picking of flowers or breaking of shrubbery is prohibited.
- No alcoholic beverages allowed.
- No excessive noise.
- No soliciting or advertising
- Each full-sized grave space may have a **full burial and cremation burial or two cremation burials. The second burial on a single lot-the stone will need to be flushed with the ground.**
- No hunting.

### **NOTICE**

### **RESTRICTIONS ON STONES:**

Effective July 1<sup>st</sup>, 1992, all Hanover Township Cemeteries will be as follows:

1. Maximum Stone Size (1 inch plus or minus all measurements) BASE- 40 inches, STONE-32 inches, HEIGHT – 24 inches.
2. Stone must have a full footer and footer must be 30 inches deep.
3. Military markers must be flush with the ground or mounted on the back of headstone.

These cemetery rules are from the rules and regulations adopted by the Board of Trustees in conformity with national state regulations for the operations of cemeteries.

Complete rules and regulations are always open for public inspection in our office.
